How we calculate scores

Many animal protection issues never receive a recorded vote in Congress. Some are enacted by voice vote, and some are introduced but don't advance. To accurately measure legislators' support, we count not just recorded votes but other meaningful ways they can help issues advance, such as co-sponsoring key bills and co-signing letters seeking increased enforcement of animal welfare laws. Dozens of animal protection bills are introduced each year; to give a balanced snapshot across a broad range of concerns, we only count co-sponsorship of a few priority bipartisan bills that have a critical mass of support and a reasonable chance of enactment.

Scores are given as percentages of the number of items counted. Legislators receive a ✓ in the Leader column and extra credit if they introduced endorsed legislation, signed a letter we requested to an agency or congressional committee, or worked with us to pursue animal welfare priorities as part of hearings, bill markups or floor debate. Those who took such actions multiple times, led a requested sign-on letter or led on a top priority issue counted in this scorecard receive double extra credit and a ★ in the Leader column. If a legislator already has a score of 100 before counting the extra credit for leadership, their score appears in bold with a plus sign.

Humane World Action Fund acknowledges the limitations of judging legislators based on a few votes, co-sponsorships, joint letters and leadership on animal issues. In some cases, legislators must miss votes for unavoidable reasons, such as a death in the family, serious illness, birth of a child or an emergency in their district. Please also consider such unrecorded matters as performance on committees, positions of House or Senate leadership, constituent service and co-sponsorship of other animal protection bills not counted in the scorecard.

President's letter

It's my privilege to share our *Humane Scorecard* for the first session of the 119th Congress. We entered this session with a new name, Humane World Action Fund, but our fundamental goal hasn't changed. We strive to produce the best outcomes possible for animals in the legislative arena. Your support is the very foundation of all that we do, and we're grateful.



We're also proud of what we have accomplished together. Viewed through my lens of more than three decades of work in Washington, this was a congressional session unprecedented in many ways. The workforce reductions in the federal government, the extended fight in Congress over the One Big Beautiful Bill Act, the Senate deliberations over federal agency appointments and judicial nominations, the longest government shutdown in American history and severe political division made it more difficult for us to keep the spotlight on our animal protection agenda. But it didn't stop us from working hard to deliver tangible results for animals through both legislative and regulatory channels.

We were able to garner bipartisan support that led to crucial victories through the annual appropriations process that funds federal agencies. For example, while many other programs were being slashed, Congress held the line on funding the U.S. Department of Agriculture's enforcement of the Animal Welfare Act (AWA), Horse Protection Act and Humane Methods of Slaughter Act, as well as programs that help domestic violence survivors with pets and encourage veterinarians to locate in underserved areas. We also secured vital provisions to prevent horse slaughter plants from reopening on U.S. soil and to advance non-animal testing methods at the Food and Drug Administration.

As in years past, the scorecard tracks key co-sponsorships and other animal-friendly actions by federal lawmakers throughout the session. This provides true accountability while also creating greater awareness and incentives for further commitment by elected officials, many of whom work hard to achieve perfect scores. We encourage you to check the ratings for your U.S. senators and representative, and share the scorecard with friends, family and other advocates so they can do the same.

Defending farm animal welfare in the face of dangerous threats

Our most important challenge in the first session of the 119th Congress was our vigorous defense of California's Proposition 12 and other state laws prohibiting intensive confinement practices in the interests of farm animal welfare and public health. We've successfully defended these laws against repeated attacks that intensified after a May 2023 U.S. Supreme Court ruling upheld Proposition 12. We've met those attacks in Congress and in the court system, and we'll continue to do so for as long as it takes.

We just marked the second anniversary of Proposition 12's full implementation, and we've secured similar gains in several other states. These measures are taking hold across the country, and we're not going back to the era of abysmal welfare standards and zero concern for the animals. We've come too far.

Defending animal welfare regulations in principle and in practice

Our other major priority in this session was the defense of regulatory standards and enforcement at a time when, in a few quarters, a strong anti-regulatory impulse has taken hold. The current administration, for example, has reduced funding at most of the agencies responsible for administering federal animal protections. While we were able to preserve funding for USDA oversight of the AWA, there's been a clear weakening of the agency's enforcement of the law. The USDA has fewer inspectors, even as the number of AWA-regulated facilities has doubled in less than a decade.

Lax enforcement of the AWA extends back several decades, under both Republican and Democratic presidents. Today, however, the situation is palpably worse. The USDA has dramatically scaled back its use of fines against research institutions, puppy mills and other regulated parties to address violations of the AWA, instead relying on repeat inspections and official warnings that do little to deter recurrent violations. A February 2025 report by the USDA's Office of Inspector General found that 80% of dog breeders reinspected during the audit period hadn't fully corrected previously identified violations. After the report was issued, the agency expanded its conciliatory approach, allowing regulated entities to escape fines, penalties, administrative actions and court orders, animal confiscation, and license suspension or revocation. Still worse, the government has bought into the dubious concept of industry self-policing, an approach we've seen fail time and again.

A chief focus of our response to this crisis in AWA enforcement has been our strong commitment to enacting the Better Collaboration, Accountability, and Regulatory Enforcement (CARE) for Animals Act (H.R. 3112/S. 1538), which garnered 192 co-sponsors in the House and 38 in the Senate by the end of the 119th Congress's first session. The Better CARE for Animals Act would strengthen the U.S. Department of Justice's collaboration with the USDA on enforcement matters, authorizing the DOJ to seek license revocations, civil penalties and forfeiture to seize animals who are suffering.

Defending animals in the second session of the 119th Congress

The scorecard highlights and scores legislation we think has the greatest potential to pass in Congress. However, we also work on dozens of issues involving a range of federal agencies with responsibilities for regulating and upholding animal welfare. These issues affect endangered wildlife, animals used in captive display or entertainment, companion animals, animals raised for food and animals in laboratories. We're fighting hard for all animals in need and distress, across the board.

With the second session of the 119th Congress now underway, please look closely at your federal legislators' positions on our priority measures. If you don't see your senators and representative listed as co-sponsors of key bills, we hope you'll reach out and ask them to promptly co-sponsor.

There's always a need for more federal legislators to assert leadership on humane issues and take the pro-animal position in all of the situations and ways that count. To that end, this scorecard isn't just an accountability tool for legislators currently in office. It's also a measuring tool and standard we can use to elect humane candidates to office in the future. These efforts are of special importance in 2026, with the seats of one third of the U.S. Senate and the whole U.S. House up for election.

We'll be intensifying our efforts this year, not just to defend our previous gains but to advance our ambitious agenda across a host of issues. We're counting on your help—and your support—to make that work a success.

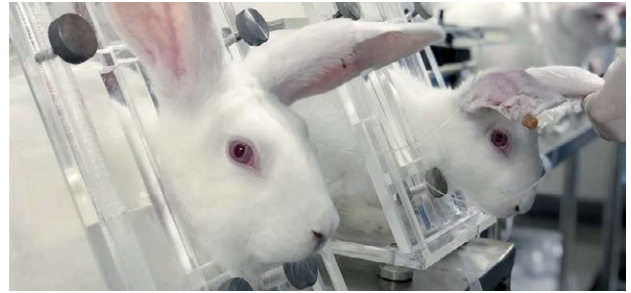
AWA enforcement

A ✓ indicates co-sponsorship of the Better Collaboration, Accountability, and Regulatory Enforcement (CARE) for Animals Act (S. 1538), which would strengthen collaboration between the U.S. Department of Justice and the U.S. Department of Agriculture to ensure sufficient enforcement of the Animal Welfare Act (AWA) and help deter violations. The AWA sets basic care standards for over a million animals in research, exhibition, commercial breeding and other facilities, yet many licensees are getting away with egregious abuses due to inadequate enforcement of the law.

While the DOJ may currently ask federal courts to issue injunctions to prevent continued unlawful mistreatment of animals, the Better CARE for Animals Act would authorize the agency to seek license revocations, civil penalties, and forfeiture to seize and remove suffering animals. It would also codify a memorandum of understanding between the USDA and the DOJ to encourage greater collaboration and ensure the DOJ has access to evidence needed to initiate cases, following related report language in prior appropriations measures. This legislation is endorsed by 120 national, state and local animal protection groups; rescues; sanctuaries; and law enforcement organizations, including the National Sheriffs' Association, Association of Prosecuting Attorneys, and National Animal Care and Control Association.

Sponsors: Sens. Richard Blumenthal, D-Conn.; John Kennedy, R-La.

Status: 38 co-sponsors; no action by Committee on Agriculture, Nutrition, and Forestry.



Leader

A ✓ indicates that the member earned extra credit for taking critical action to benefit animals, such as leading as a prime sponsor of pro-animal legislation we endorsed (including items not scored in this chart). Members also earned extra credit for co-signing any of three letters to the Agriculture Appropriations subcommittee for fiscal year 2026 or submitting a corresponding individual request. The first letter sought provisions for enforcement of the AWA, Horse Protection Act, Humane Methods of Slaughter Act and federal animal fighting law, as well as for programs to promote alternatives to animal testing, to provide shelter options for domestic violence survivors with pets through the Protecting Animals With Shelter (PAWS) grant program, and to encourage veterinarians to locate in underserved areas. The second letter urged the subcommittee to reject any language that would block state and local farm animal welfare laws. The third letter asked for a provision to permanently defund USDA horse slaughter inspections and thus prevent horse slaughter plants from ever operating in the U.S.

Puppy mills

A ✓ indicates co-sponsorship of the Puppy Protection Act (H.R. 2253) to address serious gaps in welfare standards for tens of thousands of breeding dogs and puppies at large-scale breeding operations licensed by the USDA. Although the agency upgraded dog care standards (e.g., requiring hands-on veterinary exams and 24-hour access to clean water) in a May 2020 rulemaking, in many ways the regulations still allow overcrowded, inhumane conditions at puppy mills, which often result in sick puppies being sold to consumers.

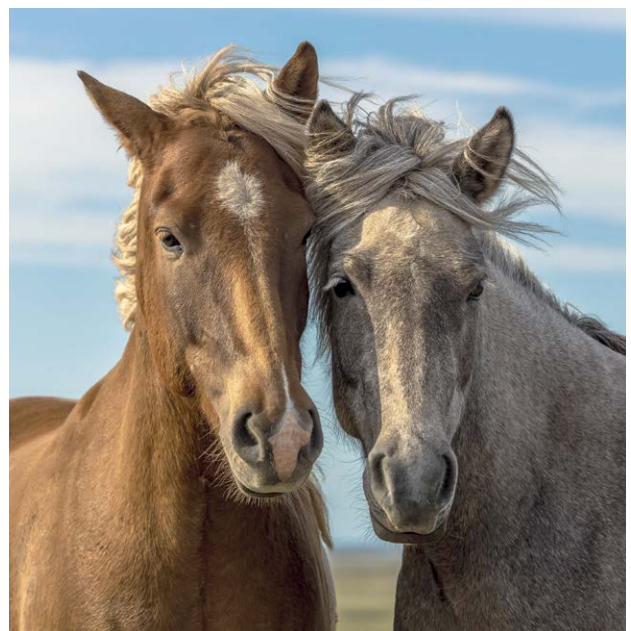
This bill, which is endorsed by the National Sheriffs' Association, would codify the 2020 rule's upgrades and make other overdue reforms, such as prohibiting the use of stacked cages and gridded or wire cage flooring, requiring space for exercise, mandating protection from extreme heat and cold, requiring prompt veterinary care for illness or injury, and requiring that breeders attempt to find humane placement for retired breeding dogs rather than destroying them.

Sponsors: Reps. Brian Fitzpatrick, R-Pa.; Jim McGovern, D-Mass.; Guy Reschenthaler, R-Pa.; Jimmy Panetta, D-Calif.

Status: 199 co-sponsors; no action by Committee on Agriculture.

Horse slaughter (SAFE)

A ✓ indicates co-sponsorship of the Save America's Forgotten Equines (SAFE) Act (H.R. 1661) to prohibit the reopening of horse slaughter plants in the U.S. and the export of American horses to slaughter for human

consumption. Horse slaughter is inherently cruel due to the unique biology of horses, and more than 80% of Americans oppose it. Horses destined for slaughter are shipped long distances without food, water or rest in crowded trucks and are often seriously injured in transit. At the slaughter plant, they often suffer repeated blows to the head during attempts to render them unconscious and are sometimes still alive when dismembered.

This predatory industry doesn't "euthanize" old, sick horses; young and healthy horses are purchased, often by buyers misrepresenting their intentions, and killed for the overseas horsemeat market. American horses aren't raised for food and are routinely given hundreds of drugs over their lifetimes that can be toxic to humans if ingested.

Sponsors: Reps. Vern Buchanan, R-Fla.; Jan Schakowsky, D-Ill.

Status: 223 co-sponsors; no action by Committee on Agriculture.

Endangered species

A ✓ indicates a vote against a floor amendment (#29) to the National Defense Authorization Act (H.R. 3838) to exempt defense-related activities from the Endangered Species Act (ESA). This anti-animal amendment would also prohibit the designation of military and certain National Guard lands as critical habitats under the ESA, exposing endangered and threatened species to unrestricted harm and possible extinction.

The U.S. Department of Defense manages nearly 27 million acres of land, including old-growth forests, tallgrass prairies, coastal beaches and wetlands, making military installations a haven for rare species. The

department has long worked with wildlife agencies to ensure it meets ESA obligations while still maintaining military readiness, and there is no evidence that compliance with the ESA threatens our nation's military security.

Sponsor (anti-animal amendment): Rep. Andy Biggs, R-Ariz.

Status: Amendment failed by 200-228 vote in September 2025.

Wolves

A ✓ indicates a vote against H.R. 845, the misleadingly named Pet and Livestock Protection Act. This anti-animal legislation would effectively force the U.S. Fish and Wildlife Service to remove ESA protections for gray wolves in the lower 48 states and block judicial review of the action, leaving wolves vulnerable to an onslaught of trophy hunting and recreational trapping. Wolves play a vital role in maintaining healthy ecosystems, benefiting many other species as well as the land. Legislating ESA decisions also undermines the law itself, which rests authority in federal agencies with scientific expertise and continues to be our nation's strongest tool for protecting vulnerable species.

Sponsor (anti-animal bill): Rep. Lauren Boebert, R-Colo.

Status: Passed by 211-204 vote in December 2025.

No action taken by the Senate on H.R. 845.

USDA and FDA animal welfare programs

A ✓ indicates that a member was one of the 185 representatives who co-signed a group letter or submitted a corresponding individual request in May 2025 to the appropriations subcommittee that funds the USDA and Food and Drug Administration. These letters sought provisions in the fiscal year 2026 funding bill for enforcement of the AWA, Horse Protection Act (HPA), Humane Methods of Slaughter Act and federal animal fighting law, as well as for programs to promote alternatives to animal testing, to provide shelter for domestic violence survivors with pets through the Protecting Animals With Shelter (PAWS) grant program, and to assist veterinarians working in designated veterinary shortage areas. The letters also requested that no provisions be included attacking state and local farm animal welfare laws.

Sponsors: Reps. Mike Quigley, D-Ill.; Chris Smith, R-N.J.

Status: The FY 2026 funding package enacted in November (P.L. 119-37) includes the requested funding for enforcement of the AWA and HPA, for the PAWS grant program and for the student loan repayment program encouraging veterinarians to work in underserved areas. It also includes helpful requested language directing the FDA to advance non-animal testing methods and for the USDA to enforce humane slaughter and animal fighting laws. No harmful “riders” attacking farm animal welfare laws are in the package.

Horse slaughter (defund)

A ✓ indicates that a member was one of the 126 representatives who co-signed a group letter to the appropriations subcommittee that funds the USDA and FDA. The letter requested a provision in the FY 2026

funding bill to permanently prohibit funds being provided for the USDA to inspect horse slaughter plants, thus preventing such plants from ever operating in the U.S.

Sponsors: Reps. Vern Buchanan, R-Fla.; Jan Schakowsky, D-Ill.

Status: The enacted legislation (P.L. 119-37) includes language preventing horse slaughter plants from reopening on U.S. soil during FY 2026.

Congressional Animal Protection Caucus

A ✓ indicates the representative is a member of this caucus, which highlights issues affecting animals and opportunities for legislators to help advance reforms. (SP indicates the member is a caucus co-chair.)

Members also earned extra credit for co-signing either of two letters: 1) a letter seeking to finalize a new office at the National Institutes of Health that would lead efforts to reduce animal testing; and 2) a letter urging the U.S. Fish and Wildlife Service to reverse the decision to cancel the release of a National Wolf Recovery Plan. A ★ indicates that the member earned double extra credit for taking two or more of these actions, leading a requested sign-on letter to a federal agency or congressional committee, or leading on a top priority issue counted in this scorecard.

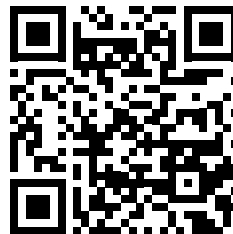
